ORDINANCE NO. 101

AN ORDINANCE OF MONAGHAN TOWNSHIP, YORK COUNTY, PENNSYLVANIA, PROHIBITING PARKING AT THE INTERSECTION OF NORTH GRANTHAM ROAD AND AL-PAT ROAD (T-888 AND T-913), A PORTION OF GIBLERT ROAD BETWEEN STONEY CREEK ROAD AND THE YELLOW BREECHES CREEK (T-894), AND A PORTION OF NORTH YORK ROAD (SR 4035) SOUTH OF YELLOW BREECHES CREEK

WHEREAS, Monaghan Township requested LTAP to perform a traffic field review regarding the possible posting of "No Parking" signage at the following three locations:

The intersection of North Grantham Road and Al-Pat Road;

Gilbert Road between Stoney Creek Road and the Yellow Breeches Creek;

North York Road (SR 4035) south of the Yellow Breeches Creek; and

WHEREAS, a field review dated August 5, 2020 supported the Township's request for parking restrictions in all three locations.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Monaghan Township, York County, Pennsylvania, as follows:

SECTION 1. Based on the results and recommendations of the traffic study performed on August 5, 2020, parking shall be prohibited at all times for all vehicles in the following locations (collectively the "Restricted Parking Areas"):

Along each approach to the intersection of Al-Pat and Grantham Roads, specifically, on the east and west sides of Grantham Road south of the intersection and on the north side of Al-Pat Road; along the northwest quadrant of the intersection of Al-Pat and Grantham Roads; along Grantham Road opposite the Al-Pat Road approach; and

Along both sides of Gilbert Road between Stoney Run Road and the Yellow Breeches Creek; along the east side of Gilbert Road between Stoney Run Road the 90-degree curve located 300' to the south; and

Along both sides of North York Road (SR 4035), south of the bridge over the Yellow Breeches Creek.

SECTION 2. Any person violating any provision of this Ordinance is guilty of a summary offense and shall be sentenced to pay a fine of \$50.00.

SECTION 3. Any vehicle which remains parked in violation of this ordinance for two or more consecutive days will be towed and impounded. In addition to the \$50.00 citation, the offender will be responsible for all towing costs and costs to release the vehicle from the impound lot.

SECTION 4. The Pennsylvania Department of Transportation's Engineering and Traffic Study, attached hereto as **Exhibit "A"**, is hereby adopted as a finding of the Township and is incorporated herein by reference and made a part hereof.


SECTION 5. Appropriate Township staff and personnel are authorized to post "No Parking Symbol" signs at the designated locations noted in **Exhibit "A"** and in accordance with the Pennsylvania Motor Vehicle Code.

SECTION 6. All other ordinances, parts of ordinances or parts of resolutions inconsistent herewith shall be and the same expressly are repealed.

SECTION 7. This Ordinance shall be effective at 12:01 A.M. on the 6th day following the adoption hereof by the Board of Supervisors of the Township of Monaghan.


